Dear RTF Community,

The Red Tab Foundation (RTF) is celebrating 40 years of kindness at a moment that is especially challenging for many in our LS&Co. community. Even while separated from one another by the pandemic, you funded \$2.4 million in cash grants to help with everyday hardships, natural disasters, and the financial impacts stemming from the COVID-19 pandemic. In a time of great need, RTF supported more individuals than ever before – more than double the amount of assistance given pre-pandemic. What's more, in a year when essential workers carried so much for all of us, 95% of employee grants went to those working on the frontlines of LS&Co.'s business.

We've also reached a milestone in our commitment to help our employees build their own safety nets. As of this year, our Red Tab Savers have collectively saved \$1 million of their own money, supported and incentivized by RTF's program.

These accomplishments are not only ours, but yours. While RTF served as a catalyst, it was you who brought the LS&Co. value of empathy to life in the middle of a global pandemic, providing a lifeline for those who needed a hand to lift them up. The numbers tell the story: our individual donors increased by 42% with contributions from employees, shareholders, and retirees at all levels. This support came from more than 30 countries, proving that we



Jerry O' Shea started as a stock boy, finished as an executive, and never for a moment lost sight of the community of LS&Co. co-workers that he cared so much for. Jerry started RTF in 1981 – 42 years into his career at LS&Co. — with \$100k out of his own pocket. As his tenure concluded, Jerry was mindful of the company's factory workers, those who'd also given their working lives to LS&Co. As his wife, Claire O'Shea, once said, "He loved the company, so he wanted to give back to other employees his good fortune."



Healing, not hardship

Eleane Perez, Logistics Sr. Analyst / Mexico

Eleane reached out to RTF when she didn't know what else to do. Her father fell unexpectedly sick and was hospitalized for several weeks. When they couldn't determine what was wrong, RTF helped with several experimental treatments. "I have no words to thank you for all the support, especially in these times of the pandemic. My dad was fighting to live and you gave me the opportunity to help him." When medical emergencies hit – often out of nowhere – finances are the last thing that families should be focused on. Medical expenses make up 11% of the hardships RTF helps with each year.

Winter Storm Unlocks Wave of RTF Advocates in Texas

Teresa Montmayor, Retiree / San Benito, TX

Teresa Montmayor started her career at LS&Co. two days out of high school in 1973. "I would measure the waist of the jeans. Then I became an instructor, then a supervisor. I worked there for 16 years. Loved my job." Teresa was among the retirees affected when the US was struck by harsh winter storms. RTF was able to provide emergency shelter, grocery vouchers, and essential home repairs for 325 families who were impacted by power and water loss or storm damages. "Thank you again for all the help RTF does for employees and retirees. It is greatly appreciated." Forty-eight years later, her former coworkers still gather annually for their "Levi's Roundup" reunion, and Teresa now strongly advocates for RTF.




Red Tab Kids: School Books & Distance Learning Grants

Adam Piwonski, Manufacturing Facility Foreman / Plock, Poland

Adam has found himself at various times both a recipient of RTF's support and among the donors that pays it forward. "I make contributions through monthly payroll deductions," he tells us. "During the pandemic, we had online education and my daughter was using my phone to connect. I received support for distance learning tools. She can now use computer equipment which allows her to see everything clearly and is very happy because of that." Across our manufacturing facilities in Poland and in South Africa, RTF helped with 288 grants to help the children of employees with educational expenses.

Boerewors Rolls Fund RTF in Cape Town

Over the last year, RTF support in our South African manufacturing facility has increased 189% in the midst of COVID-19. In turn, local donors have stepped up to help their peers. Zikhona Mene is an HR Operations Specialist at the facility who decided to take action. "We sell a lot of Boerewors rolls (like hot dogs) here in Epping to raise funds for the Foundation because RTF has been a lot of help for us here. Thank you so much for what you do."





Nuholt Huisamen, Managing Director, East Asia-PAC Singapore

Last year's first ever virtual (Run) for Red Tab brought together 665 employees to spend their Sunday afternoon getting active to support their fellow employees.

People in 30 different countries and six continents were running, walking, swimming, biking and more to ultimately raise \$120K. Nuholt Huisamen was the top individual fundraiser, and his Singapore team also raised \$15K, taking home top honors. "RTF is extremely dear to my heart after spending the best part of my 18-year career working at the plant in South Africa. I've witnessed how RTF made a significant impact on the lives of my fellow employees. Whenever I get a chance to get involved or to contribute, I jump at it."



What I've really appreciated about RTF is not only the empathy of caring for our employees, but also how quickly they were helped. This is the difference in how that employee is able to be at work, remain at work, and thrive at work. Hardships can happen for any of us and it's good to know that there's somebody out there who cares, will listen, and try to help.

Emergency Travel in the Era of COVID

Kratina Freeman, Quality Control Auditor / Henderson, NV

Kratina has worked as a distribution center employee in Nevada for three years, and is a newly found caretaker for her granddaughter. "One day I received a phone call telling me that my brother has coronavirus... devastating news. I had never planned for something like this." Kratina hoped to drive herself and her granddaughter from Nevada to California to pay their final respects, but didn't have the finances to make the trip happen. RTF is able to intervene in situations like Kratina's and help with a grant that can prevent people from turning to predatory debt cycles like payday loans or other high interest solutions that can spiral into further debt, "After being connected to RTF, I was amazed at the response that I got from them. Their support helped me mentally, emotionally, and financially."

As people's delicate financial lives were turned upside down, RTF changed our program guidelines to adapt and meet ever-changing needs. We offered no-interest loans to furloughed employees and installed an expedited grant process to get funds to people who needed it as quickly as possible. We also extended our program guidelines to cover tech tools for kids undergoing remote learning, additional childcare, the burden of higher transportation costs and more.



Building a safety net

Red Tab Savers is a matched savings program for retail and distribution employees, helping them build their own financial safety nets for when hard times hit.

Employees reach one million in personal savings

Bianca Landaverde is among the more than 1900 employees that have built their savings muscle through Red Tab Savers. Six years in, the program has now helped participants save over \$1M, enabling them to create their own safety nets when everyday hardships happen. "At first, I joined Savers just to prove to myself that I could do it, but now that I've had another child, I'm saving towards getting a bigger vehicle so we can all fit comfortably. I opened a savings account just for the program and I continue to deposit money every paycheck. I have yet to make any type of withdrawal from that account."



Assistance by grant category




Pete Haas Jr. / Decades dedicated to service


Connect the LS&Co. community


